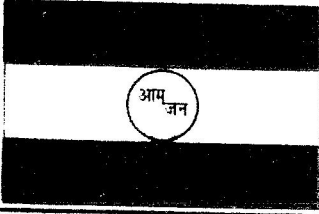

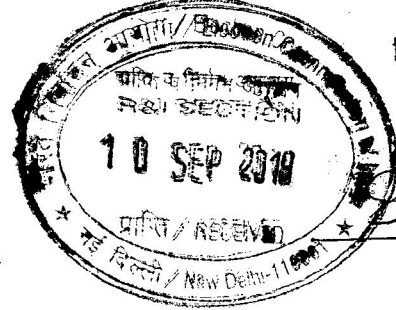

जिसके मुख्य बिन्दु निम्न प्रकार है :-

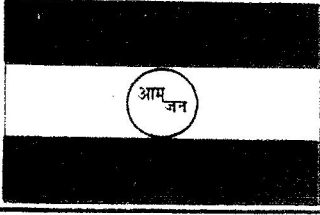
- 1 पार्टी ने वर्ष 2016-17 में कोई सहायतार्थ चन्दा नहीं लिया (जो नगण्य है)




